

Safeguarding Adult **Reviews** (SARs)

We published the SAR in respect of 'James', undertaken with the North Yorkshire Safeguarding Children Partnership (NYSCP) and their partners.

An action plan is being jointly developed and an update will be shared in our annual report for 2023-24.

Local Government Reorganisation (LGR)

On 1 April 2023, the County Council and seven district and borough councils in North Yorkshire merged to become one unitary authority. Throughout the process, partners ensured their focus on safeguarding was strong despite widespread organisational changes. Moving forward, LGR opens up opportunities for improved joint working on Safeguarding.

Policies and Procedures

We purchased Tri-X, an online platform for the Multi-Agency Safeguarding Adults Policy and Procedures offering automatic updates on legal changes and development of new guidance.

We also reviewed the Safeguarding Adults Review (SAR) policy against best practice and identified areas for further development over the next 12 months.
